Instructions: Authors submitting a publication to this conference should complete pages 1, 2 and 3 (Publication Agreement) to allow SRNL to include your work in the proceedings for this conference. If an author does not own the copyright for their work (*e.g.*, created during the course of your employment as work for hire) the appropriate copyright owner (*e.g.*, employer) should sign the Publication Agreement in Box B.

If there are multiple authors listed for the same publication a single author may sign the Publication Agreement on behalf of all authors if authorized to do so. Should the signing author not be authorized to sign on behalf of all other listed authors, a notation to that effect should be made on page 2 of this form (*e.g.*, by striking a single line through the sentence beginning “If there are multiple co-authors, the signing author...””) and the remaining authors should also complete and submit a Publication Agreement.

All authors of work sponsored under a government contract or grant should sign in box B. If any authors listed for a publication are or were officers or employees of the US Government at the time the work was created then any government author, or appropriate agency representative, should sign in Box C – leaving Box B blank if all are employees of the US government. If any co-authors are not US Government employees, the non-Government co-author(s) should sign in Box B.

All individuals making a presentation at the conference (including contractor, grantee, or US Government employee) must complete page 4 (Presenter’s Release). A Presenter’s Release must be completed for each individual presenter.
