The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the Ministries of Foreign Affairs of the IAEA's Member States and has the honour to request that they draw the attention of the appropriate governmental authorities to the forthcoming **Technical Meeting on Lessons Learned from the Russian Research Reactor Fuel Return Programme** to be held in Charleston, South Carolina, United States of America, from **20 to 23 June 2016**.

The purpose of the meeting is to share detailed lessons learned from efforts to return fresh and spent research reactor fuel to the Russian Federation as part of the tripartite Russian Federation–IAEA–United States of America initiative known as the Russian Research Reactor Fuel Return (RRRFR) programme.

The attached Information Sheet provides further details of the meeting.

The meeting will be held in English with interpretation into Russian.


Member States are invited to designate one or more participants for this meeting. Member States are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the meeting. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Such assistance may be offered upon specific request to up to two participants per country provided that, in the IAEA's view, the participant(s) on whose behalf assistance is requested will make an important contribution to the meeting. The application for financial support should be made at the time of designating the participant(s).

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in meetings, workshops or training courses or for consultants. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.
